Results of the e-voting at 28th Annual General Meeting (AGM) of M/s B R D Finance Limited held on Saturday, 30th November, 2023 at 11.00 A.M and remote e-voting facility based on the report of the Scrutinizer to the voting process C.S M. In view of the continuing COVID-19 pandemic, the Ministry of Corporate Affairs ("MCA") has vide its circular dated May 5, 2020 read with circulars dated April 8, 2020 and April 13, 2020 and January 13, 2021 and 28th Deember, 2022 (collectively referred to as "MCA Circulars") permitted holding of the Annual General Meeting ("AGM") through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"), without the physical presence of the Members at a common venue. The company had provided the facility of remote e-voting to the shareholders to enable them to cast their vote electronically on the resolutions proposed in the Notice of the AGM. The remote e-voting was open from Wednesday, 27th September, 2023 to Friday, 29th September, 2023. In addition, e-voting was conducted during the 28th AGM to facilitate those members who have not exercised their votes through remote e-voting.
